CFAD Update

The newly minted Committee on Faculty Affairs and Development (CFAD) was created this summer with the goal of addressing needs to improve faculty work. CFAD identified two collateral projects: 1) creation of a faculty handbook and 2) review of MDFMR's committee structures to create a map for communication and decision making. CFAD had a productive retreat on 9/13 and developed a shared understanding of the committees at MDFMR, discussed recommendations on who each committee should serve/represent (FM vs. subspecialty vs. all), and began to delineate a structure of communication that interfaces with the leadership organization chart. Next steps include bringing findings and recommendations to leadership for discussion. After this meeting, further updates will be provided to all faculty.
